Welcome and Introductions

Merced County Tobacco Control Program (MCTCP) - Updates by Program Manager (PM)

- 1. TRL with provision to eliminate the sale of flavored tobacco products in the city of Atwater; presenting at the Atwater city council meeting in April for an educational presentation
- Los Banos (LB): working on implementing smoke free outdoor areas working with the youth coalition.
 Program youth coordinator created this youth group in LB and they are getting ready to attend youth quest
- 3. Welcoming new community engagement coordinator to the program

Merced County Department of Public Health (MCDPH) - Updates by Health Education Specialist (HES)

Department of justice grant – recently received; work will begin. Some areas of focus include:

- i. Tobacco sting operations in Merced
- 2. In April beginning the collaboration with MCTCP. MCDPH is subcontracted under the MCTCP
 - ii. Working on tobacco retail license (TRL) in Merced
- 3. MCDPH has been able to attend and collaborate with MCTCP and join in on the youth coalition meetings in Merced

Presentation: California Health Collaborative (CHC)

The CHC Program Director (PD) presented on the CHC, providing more information about this nonprofit organization founded in 1982. There are three tobacco control programs under the CHC.

Presentation: ACCT Coalition

The MCTCP PM provided a presentation on the ACCT Coalition

- i. The MCTCP contains a community engagement component which is how the ACCT Coalition was established in 2010. Formally known as the Merced County Tobacco Control Coalition.
- ii. Serves as an advisory board for the MCTCP

ACCT Coalition Members Concerns

The "right" people are not at the "table": Those with funding sources and more power to get across to our youth are not present at our coalition events.

- i. How can we overcome this obstacle: It is agreed upon that individuals are missing at the "table".
 MCTCP staff have done their best in inviting these individuals to ACCT Coalition events and reaching out to them, however, many times we don't receive the support that we hoped for
- ii. It is highly encouraged that coalition members get involved and invite those individuals to attend coalition events and form part of our discussions
- iii. Merced Police Department Representative: "Although we have individuals missing, it is important to showcase that who IS present is enough to create change." Waiting on folks to show up, you're just going to be waiting on folks to show up."
- iiii. CHC PD: reiterate, we cannot, out of caution, reach out as funded staff and offer services and education because we would be putting our contract in jeopardy. As a community led coalition, we have the power to go out and invite these individuals and advocate for the coalitions goals. Staff is able to provide up to date information and the tools needed for coalition members to go out and invite these individuals

Presentation: Healthy Stores for a Healthy Community (HSHC) Campaign

MCTCP PM presented on (HSHC)

i.

- To improve the health of Californians through changes to the retail environment
 - a. Going out to retail stores and collecting data regarding tobacco, alcohol, condoms & food
 - b. In Merced County there are 152 Stores to be surveyed
 - i. The dates for the trainings will be distributed

Presentation: Tobacco Retail Licensing (TRL)

ACCT Coalition Chair presented on TRL's

- i. TRL's are a way to reducing illegal tobacco retail sales to minors
- ii. All tobacco retailers are required to obtain a license and renew it annually
- iii. TRL's are one of the goals for both the ACCT coalition & MCTCP
