
Join Our Advisory Board

PUBLIC OPINION SURVEYS

Earlier in November, the Si Se Puede team finished gathering public opinion surveys in Orland and Gridley, and the results are in! Here is what we learned from respondents in the community:

Orland

Gridley

 & 63% strongly agree that tobacco litter is a problem in the community.
& 93% support a local policy that requires store owners to have a local license to sell tobacco.
& 81% support a local policy that requires store owners to have a local license to sell tobacco.

STRENGTHING POLICIES

Another big step was taken to hold Big Tobacco and tobacco retailers accountable for selling illegal flavored tobacco products in California. Assembly Bill (AB) 3218 was signed into law, along with Senate Bill 1230. These bills strengthen the decision made by California voters to protect kids by ensuring illegal flavored tobacco products stay off retail shelves.

Big Win: California holds Big Tobacco and retailers accountable for selling illegal flavored tobacco products.



Key bill highlights:

 Requires tobacco and nicotine manufacturers and importers to submit a list of their products and provide proof that they are unflavored to the California Attorney General, who will establish and maintain an official Unflavored Tobacco List by December 31, 2025.

 Prohibits the sale of products not listed on the Unflavored Tobacco List – whether it be in stores, online, or via delivery services.

 Imposes additional penalties for any seller violating the law and give the @cdtfa and local law enforcement the authority to seize illegal flavored tobacco products from retailers and wholesalers.

- More clearly defines "flavored" tobacco
- Expands the definition of "nicotine" to include synthetically-derived nicotine, ensuring many products that have been introduced to sidestep the law are captured.



Cessation Resource

The holiday season, with its stress and social gatherings, can make it even more difficult for people to resist the urge to smoke. Whether it's the pressure of holiday preparations or the desire to fit in at parties, these triggers can increase smoking behavior. However, there are resources available to help. Programs like Kick It CA offer free cessation services, including counseling and support, to help individuals quit smoking and manage cravings. If you're struggling this season, reaching out to a support service can make all the difference in staying smoke-free.
